What is an evidence-based practice?

"conscientious, explicit and judicious use of current best evidence in making decisions about the care of individuals"

"the integration of best research evidence with clinical expertise and [client] values"



The "Evidence" Hierarchy

Systematic review/meta-analysis of all relevant randomized controlled trials

Evidence-based clinical practice guidelines based on systematic reviews of RCTs


Evidence obtained from at least one well-designed RCT

Evidence obtained from well-designed controlled trials without randomization and from well-designed case-control and cohort studies

Evidence from systematic reviews of descriptive and qualitative studies

Evidence from a single descriptive or qualitative study

Evidence from the opinion of authorities and/or reports of expert committees

1. Asking the clinical question


2. Searching for the best evidence

3. Critically appraising the evidence

4. Addressing the sufficiency of the evidence – to implement or not to implement

5. Evaluating the outcome of evidence implementation

One of the greatest liabilities of history is when people fail to remain awake through great periods of social change.


Society has its protectors of the status quo and they are notorious for sleeping through revolutions.

Fostering leadership skills at all levels


Conditions of Collective Impact
