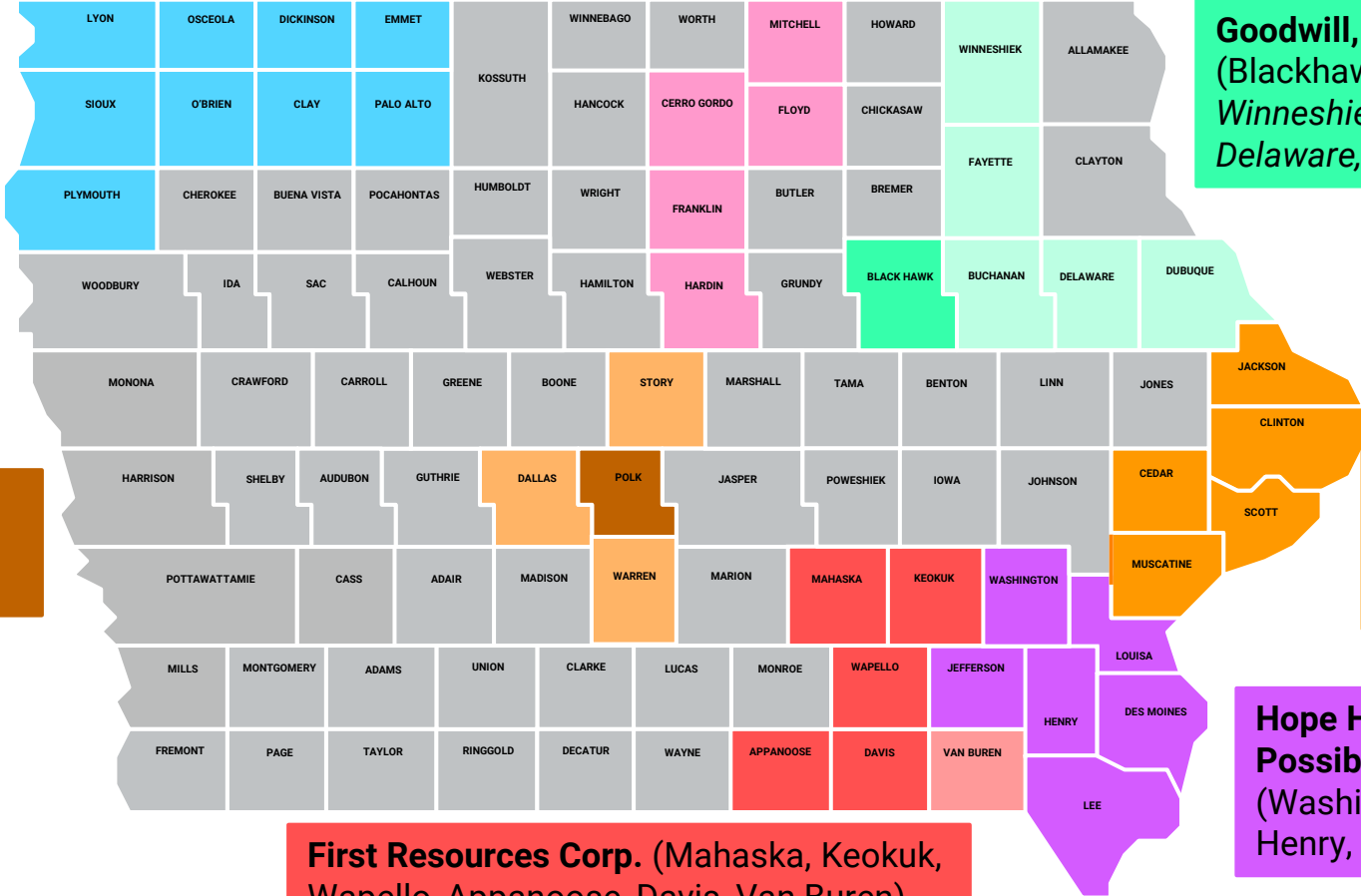


Individual Placement and Support (IPS) Service Area
